Blue Ribbon Diversity

Year 2005 Blue Ribbon Finalists cover a broad array of land use activities.

Retail projects include supermarkets anchored by Big Y and Shaws, and a new Audi dealership in New London, Bernies in Enfield and a new multistory Target located in downtown Stamford.

Residential finalists include The Hawthorne at Gillette Ridge, The Goodwin Estate, and The Ledges Apartments.

Profit oriented, corporate headquarters include Diageo's North American Headquarters, ADVO Headquarters and Schoenhardt Architecture + Interior Design.

Several finalists are educational institutions: CREC's Polaris Center in East Hartford, Waterbury Performing Arts Magnet School, SCSU Residence Hall; the SS&C Technologies Financial Accelerator @ The UCONN School of Business Graduate Learning Center; the Wesleyan University Center for Film Studies; the CCSU Energy Center.

Social service related projects with an educational component include the Asylum Hills Boys & Girls Club, and the Central Connecticut Association for Retarded Citizens, Inc. office and training facility,

Arts and communication related projects include the Connecticut Public Broadcasting Headquarters; Wesleyan University Center for Film Studies; Waterbury Performing Arts Magnet School, and renovation and restoration of the Palace Theater.

Complex and mixed use developments include The Foxwoods Rainmaker Expansion and The Mercantile Exchange.

Entertainment related facilities include: Foxwoods Rainmaker Expansion and Gillette Ridge Golf Club.

Market participants include The Mashantucket Tribal Nation; major retailers; educational institutions; an automobile dealer; profit-oriented developers; joint ventures; non-profit, educational institutions; social service organizations; and a public broadcaster.

The size of individual projects vary, from modest offices to large head-quarters employing 1,000 people.

Waterbury Performing Arts Magnet School, 16 South Elm Street, Waterbury. Naugatuck Valley Development

Corporation. Visual arts classrooms; small theatre performing and practice venues including 225 seat stage, a large dance studio and recital hall.

Rainmaker Casino Expansion, Mashantucket Pequot Tribal Nation. Located at Foxwoods Resort Casino, Mashantucket; 120,000 s.f. of casino and bingo space; with food and beverage outlets, retail outlets and parking garage.



Southern Connecticut State University, New Residence Hall and parking garage; 615

Fitch Street, Hamden. A five story, 120,000 s.f. residence hall.

Charter New Fairfield Shopping Center, a 67,000 s.f. retail center located at Routes 37 and 39, New Fairfield, CT., anchored by a Shaw's supermarket. Developed by Charter Realty & Development Corp.



Gillette Ridge Golf Course, developed by Gillette Ridge Golf, LLC, a

Drive, Windsor. 28.96 acres of land; 170,425 s.f. of building including warehouse, manufacturing, office, research and development center and an amenity support facility.

Bernie's TV & Appliance Headquarters, Store & Warehouse; Warehouse, corporate office space, retail space. Redevelopment and expansion of 1559 King Street, Enfield, CT. Developer Philip DiGennaro of Sound Enfield Group.

Palace Theatre, Naugatuck Valley



Development Corporation; Renovation and restoration of the Palace Theater; a 1920 historical land-

The facility houses classrooms, cafeteria, gymnasium, health, clinical and administrative offices.

Target Corporation, creation of a Target Store, 21 Broad Street, Stamford; in an atypical two story structure atop a parking garage in downtown Stamford.
